With conservation issues so prevalent, the Authority has many opportunities to provide leadership in the wise use of our natural resources. We work with our watershed municipalities programs that contribute to the health and well being of the environment. Our water and land management

The Authority has been implementing capital improvement projects at a number of conservation areas for the comfort and safety of our visitors and I'm pleased to note that these improvements are paying off. Several of new events were initiated, contributing to a notable

I've had the privilege of serving as the General Manager/Secretary-Treasurer of the Niagara Peninsula Conservation Authority for 24 years. # WATER MANAGEMENT Tony D'Amario, Director, Water Management

The Watershed Management program makes up approximately 40% of the Authority's operations and is comprised of a number of activites.

# HIGHLIGHTS OF THE 2007 WATER MANAGEMENT PROGRAM:

## **BINBROOK DAM EMERGENCY SPILLWAY**

In order to meet current Ontario Dam Safety Guidelines, the Authority commissioned the re-design of the existing Binbrook Dam emergency spillway, with funding from the Ministry of Natural Resources, Water Erosion Control Infrastructure Program. Construction was started in late 2007 and will be completed in the spring of 2008.

#### FLOODPLAIN MAPPING

In 2007, the Authority commissioned and undertook the generation of floodplain mapping for 20 Mile Creek from Hamilton to Lincoln, 15 and 16 Mile Creeks in Lincoln, 2, 4, 6, and 8 Mile Creeks in Niagara-on-the-Lake, Kraft Drain, Black, Beaver, Miller and Six Mile Creeks in Fort Erie.

### FLOOD FORECASTING AND WARNING

In 2007 the Authority issued 5 Watercourse Safety Bulletins advising the public of high water conditions due to snow melts and heavy rainfalls. The Authority finalized a new flood prediction computer model for the Welland River to improve the speed and accuracy of the Flood Forecasting & Warning capabilities.

#### NPCA REGULATIONS AND VIOLATIONS 155/06

The Authority issued 78 permits under O. Reg. 155/06. Previously the most permits approvals issued in one year were 44 (2006). While the vast majority of regulation violations are resolved out of court, the NPCA obtained convictions against 2 landowners in 2007. Other charges and violations are pending before the courts.

#### PLANNING PROGRAM

The Authority experienced a significant increase in applications. In 2007 staff reviewed 20 Subdivision Applications, 4 Secondary Plans, 14 Site Plans, 20 Zoning Bylaws, 11 Official Plans, 54 Consents, 42 Minor Variances, 33 Niagara Escarpment applications, 186 Municipal Building Permit Reviews and the Fort Erie Official Plan. In June, the Authority Board approved the Memorandum of Understanding developed as part of the consolidation of the Region's Planning Review function.

### SOURCE WATER PROTECTION

The Clean Water Act was proclaimed in July 2007. In September the Province appointed Mr. Mark Neufeld as the Chair of the Niagara Peninsula Source Protection Committee. The 9 member Source Protection Committee was formed in November 2007 and held its first meeting in December. The committee will work towards its mandate of completing a Source Protection Plan for the area over the next 3 to 5 years.

#### WATER QUALITY PROGRAM

The Water Quality program completed its 5th year of surface water quality data collection. This is an important component of the Water Management program, and is the most extensive stream monitoring network covering the Niagara Peninsula. Sampling was undertaken at 60 sites, including 20 sites for benthic sampling. In 2007 additional monitoring sites were added on Lake Erie and the upper 12 Mile Creek.

#### COMMUNITY OUTREACH

The Authority was pleased to produce a Native Plant Guide to promote the benefits of gardening with native plants. A number of public workshops were held to garner awareness of this resource and encourage landowners to incorporate native plants as part of their landscape. The Yellow Fish Road program which was initiated in 2006 was continued with the support of all the watershed municipalities. The Eco School program was successful in its second year with 29 schools participating. Through this program students benefitted from learning by doing; giving them an awareness and a new respect for the environment. In 2007, a Public Day was added as part of the Niagara Children's Water Festival. The event took place at Ball's Falls Conservation Area on Sunday, September 16 and an estimated 4,000 people were in attendance. Over 5,000 grades 3 and 4 students attended the 5th annual Water Festival which is a partnership of the Niagara Peninsula Conservation Authority, the Region of Niagara, City of St. Catharines and Ontario Power

#### WATERSHED RESTORATION

The Authority's Watershed Restoration program is "where the rubber hits the road" The program is important to the long term improvement of our natural resources and water quality. In 2007, the Authority in partnership with landowners and other partners invested over \$1.5 million towards restoration projects. These include: 11 manure storages; 2 milk-house washwater treatment systems; 2 trickle irrigation projects with a water savings of approximately 8,500,000 gallons; 82 acres planted with native trees and shrubs; 1 Butterfly Meadow project; 8+ acres of restored wetlands; 2 grassed waterways; over 1.5 km of riparian restoration; 400 meters of windbreak planting; 800 meters of hedgerow planting; 2 stream fencing projects totaling 1 km of stream; 2 streambank erosion control projects; 1 gully erosion control project; 1 nutrient reduction stream restoration projects and 2 constructed wetland projects (filtering tile and overland drainage). The Authority, with special funding assistance from Ontario Power Generation, continued significant restoration work on the Welland River watershed. A major project undertaken was the E.C. Brown Constructed Wetland, a property purchased from a local farmer. Historically, the property retains water for extended periods due to the low-lying, heavy clay nature of the soil and is prone to extensive flooding. The land was identified by the Authority as a priority area for restoration to its historic wetland potential. The project has made a significant contribution to achieving the goals outlined in the Conservation Authority's Welland River Strategy by increasing wetland coverage in the Welland River by 21 acres. This is an important accomplishment as very few wetland areas exist along the main channel of the river.

### NATURAL HERITAGE AREAS INVENTORY

In 2007 over 300 sites were assessed as part of this project. Numerous samples of rare species and species at risk were found.

## **HIGHLIGHTS OF THE 2007** LAND MANAGEMENT PROGRAM:

#### **BEAMER MEMORIAL CONSERVATION AREA**

Hawk Migration inventory continued this year in conjunction with the Niagara Peninsula Hawkwatch. On April 6th, the Authority unveiled a commemorative plague by Carolinian Canada Coalition designating the Conservation Area as a signature site.

#### **BINBROOK CONSERVATION AREA**

The Glanbrook Conservation Committee provided assistance with projects at Binbrook C.A. including various fishing derbies and ongoing maintenance work. Capital improvement amenities were completed including a new children's fishing dock, splash pad, gatehouse and workshop.

### **BALL'S FALLS CONSERVATION AREA**

relatively smoothly although some delays were experienced. New programming initiatives including the addition of new workshops, special events and other education programs were well attended and received. A number of capital improvements on the heritage buildings were completed.

# CHIPPAWA CREEK CONSERVATION AREA

The warm dry summer contributed to a successful camping season, but did have an impact on the water system. Staff trucked in municipally treated water to ensure that a good supply of safe water was always available. Increased site activity and vegetative buffers have helped resolve problems in keeping Canada Geese population down around Dils Lake.

# GORD HARRY CONSERVATION TRAIL

On April 19, the former Wainfleet Rail Trail was re-named the Gord Harry Conservation Trail in recognition of former Chairman Gord Harry. A ribbon cutting ceremony was attended by over 300 people. The trail is well used by bicyclers, hikers and equestrians.

#### LONG BEACH CONSERVATION AREA

Long Beach enjoyed a strong campground attendance in spite of the numerous beach postings. The hot dry summer had an impact on the water treatment plant, but staff took all the necessary precautions and were able to ensure a safe water supply at all times.

## MORGAN'S POINT CONSERVATION AREA

The Ontario Trillium Foundation compiled a documentary and included the restoration project at Morgan's Point in the production. In addition, the OTF recognized the Wainfleet Lions Club and the Conservation Authority with a "Great Grants Award" for the restoration work at Morgan's Point. Lion's International magazine also featured a story on the partnership efforts that helped to bring this project to fruition. The conservation area continues to be well used by residents and visitors and members of the Lion's Club continue to assist the Authority with ongoing maintenance.

# MUD LAKE CONSERVATION AREA

Wetland Restoration efforts continued and monitoring shows an increase in habitat diversity. Birds such as Great Blue Heron and Common Egret have been observed using this site. Monitoring of water levels and changing habitat continues to assess the effectiveness of management activities.

## ST. JOHNS CONSERVATION AREA

The Authority continues to stock the pond with Rainbow Trout and despite inclement weather, over 200 avid anglers attended the opening day of Trout Fishing season April 28th .

### WAINFLEET BOG CONSERVATION AREA

Restoration of the bog wetland is progressing at the site. Monitoring indicate an increase of several bog plant species including sphagnum moss. This is a result of moister soils, slower water loss, and groundwater levels being closer to the surface. In July 2007 an abandoned gas well was also plugged to prevent the potential for affecting groundwater quality. The most environmentally friendly and timing techniques were used.


### WAINFLEET WETLANDS CONSERVATION AREA

The monitoring program showed an increase in the variety of plants and animal inhabiting the site. The information will be used to track the progress of ecosystem restoration on this property.

- » Awarded 4 bursaries, in conjunction with the Fort Erie Conservation Women's' Auxiliary, to support students pursuing conservation-related studies


