Brian Baty cautioned our communication asking citizens to have power over the board, as this may cause a disruption with our partners. Barry Sharpe mentioned the purpose of the committee in the press release is to develop a process for implementing new

Regulatory levels for the entire Welland River when they are available. Open public information sessions are something for the working committee to establish. Also, need to look at a way to have the public involved as part of the implementation committee.

The Welland River agenda tonight included a recommendation to be presented to this board leading to the structure and makeup of committee appointees. The presentation by the consultant was the only item accomplished in the time allotted for this meeting.

Barry Sharpe liked the idea of having a public liaison, and Brian Baty suggested when the next meeting is scheduled invite floodplain landowners to keep the conversation open.

David Barrick made a motion the board endorse the principal there be public members on the floodplain implementation committee, seconded by April Jeffs and carried by a recorded vote.

The above motion doesn't show how many public will be involved. The committee will meet and come back with the terms of reference and how to choose the members involved. First we have to establish the principal of having public representation on the committee.

## (10) (7) 2011 FINANCIAL STATEMENTS

He noted that the information contained on page 2 approximately the middle of the page, left hand column the numbers show effectively the authority broke even mainly due to land acquisitions and things are quite stable at this point.

Doug Joyner asked what the deferred Welland River Restoration / Ontario Power Generation means? The CAO explained the NPCA received approximately 3 million dollars from OPG 6 or 7 years ago, and this money was allocated for project improvements, not floodplain mapping.
