4. Chair's Remarks

The Chair highlighted some positive work the NPCA accomplishes in the area of Conservation and the Management of our Natural Resources;

- Timms attended the announcement made by MPP Jim Bradley for a Provincial grant established under the Great Lakes Protection Act, issued to the Niagara Restoration Council. The Great Lakes Guardian Fund is a Provincial program which allows a maximum funding of \$25,000. In addition, NPCA contributed \$15,000 from the Restoration Grant Program and Niagara Region contributed 500 tons of compost; a partnership which will result in building 4 (four) pollinator gardens in Port Dalhousie, 2 (two) in Rennie Park and 2 (two) on Henley Island. The NPCA is represented on the Great Lakes Guardian Council through Conservation Ontario's President Dick Hibma.
- On May 7th, the Chair took part in planting 10 trees with NPCA staff and volunteers in the Green Ribbon Trail Park, funded by the City of St. Catharines.

These two events highlight some work the NPCA is doing in the 12 Mile Creek Watershed implemented through NPCA's Restorations team.

- On May 10^{th,} the Chair attended the Niagara Home Builder's Association dinner where the President provided the Home Builder's perspective regarding the CA Act Review, Greenbelt Act and the various Policies currently under review by the Province.
- Timms was pleased to attend the Centre of Excellence hosted by the Town of Lincoln, led by Mayor Easton in partnership with Niagara College; this event also had representation by NPCA members Hodgson, Mayor Joyner, Mayor Jeffs and Mayor Darte. This was a great contribution to the agricultural permit guide that will be used by the NPCA.
- In partnership with Niagara Region, the Chair further participated in the Niagara Children's Water Festival and was happy to receive a \$5,000 cheque from RBC's Blue Water Program towards this educational initiative.

5. CAO Comments

- CAO, D'Angelo reminded members about Phase 2 of the CA Act Review. One of the response sessions is scheduled for June 9th in London, ON. We will be working with the local municipalities and the Region of Niagara on a joint submission with the area planners, and also with Conservation Ontario and the other 35 Authorities on a unified position. A staff report will come back to the board with recommendations should the board wish to adopt for an individual response from this Conservation Authority.
- Niagara Children's Water Festival held May 3-10th at Ball's Falls in partnership with Niagara Region, hosted approximately 5000 students and 120 volunteers; a very successful event, teaching students about conservation and water.
- NPCA staff is now gearing up for the Thanksgiving Festival.

Member Comments:

- Member Annunziata commented on the need for a solution to expedite the permit application process at the NEC (Niagara Escarpment Commission) which is currently under-resourced and creating a problem for investors. It was suggested that NPCA staff liaise with area planners to bring forward this issue; local planners are trying to put together a strategy to deal with the low benchmark for permit processing at NEC. It was noted that this situation be addressed in the commentary to the Province.
- Member Baty provided some rationale to the challenges the NEC is facing with the backlog of permits and advised that with the NEC Plan Review, we anticipate the Province's recommendations will be forthcoming. Member Annunziata appreciates the comments, however, would like to see some predictability, "it's mandated by planning staff at local levels, by the NPCA and there should be predictability in the turnaround of permit applications in a timely manner by the NEC" and further asked that member Baty assist in bringing this message to the NEC.
- Member Baty inquired about the Niagara Children's Water Festival and whether staff might weigh the merits of holding the Water Festival in the Fall vs Spring. It was suggested that staff review Educator's responses.
- Member Hodgson commented on the Greenbelt Plan and the opportunity to respond to the "apparent double standard which imposes protected policy on private lands and farmers".

- Member Baty requested that through our media resources, the public be made aware of the risk of lyme disease and the ticks present on our conservation properties such as the Wainfleet bog.
- Member Baty requested staff investigate the storm water management in Fonthill and the
 potential augmentation of water in the new subdivision. Staff reported that the watershed
 team viewed the site, are currently investigating and will report back to the board with its
 findings.
- Kathy McQuire, President of Port Colborne Conservation Club, spoke to members about
 this Club which has been active now for 62 years. It offers trap and skeet ranges every
 second Sunday; it has a walleye pond and hatchery; club provides instruction for youths;
 kids fishing derby (Kid's derby on Father's day); archery and air gun field target and duck
 race which takes place on Canal days to mention just a few activities this club provides.
 Members were invited to tour the club.

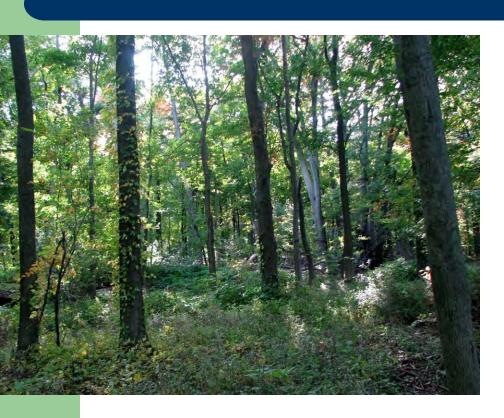

We are proposing a *Natural Heritage Park* be established on the Parks Canada Lakeshore Road site



 To create a natural heritage park consisting of recreational and educational amenities

The Lakeshore Road property is filled with important natural and historical features



- The Battle of Fort George National Historic Site
 - Site of American landing and fierce fighting in May, 1813
- A Carolinian forest, meadows, creeks and wetlands
- Lake Ontario waterfront
- Additional heritage interest
 - Secord farm, U.E.L settlement
 - First Nations hunting and fishing
 - DND training

The establishment of a park would be an important step towards habitat conservation and wildlife protection on the site



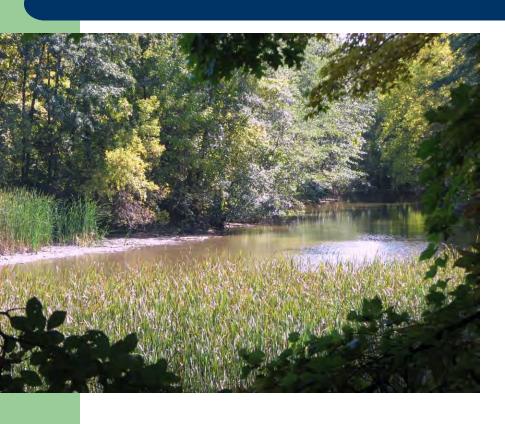






- Species-At-Risk need protection

When fully operational, future possibilities exist for the park to offer a range of heritage and nature based experiences such as

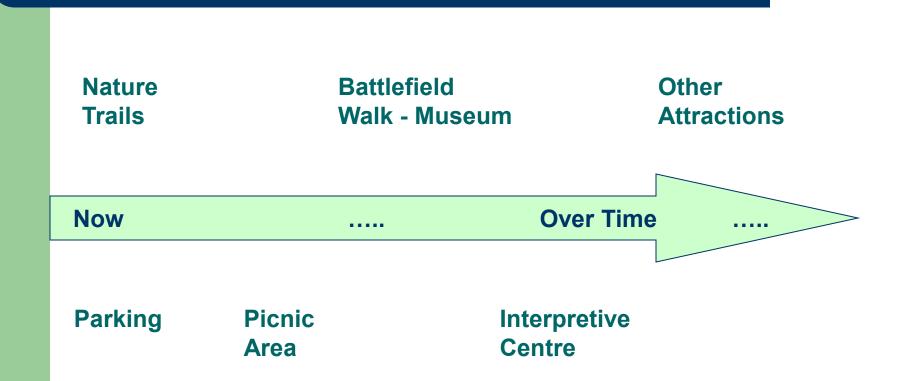


There is potential to retain the existing sewage treatment building for developing a gateway to the site's natural and heritage attractions

Niagara Bruce Trail Club

We are one of nine member clubs of the Bruce Trail Conservancy, a charitable organization committed to establishing a conservation corridor containing a public footpath along the Niagara Escarpment, in order to protect its natural ecosystems and to promote environmentally responsible public access to this UNESCO World Biosphere Reserve. About 8m Ontario residents live within 90 minutes of this natural treasure, and the Bruce Trail.

• The Niagara Bruce Trail Club maintains the southern-most portion of the Bruce Trail, the 80 kms from Queenston to Grimsby plus 40 kms of side trails. Our hiking program not only includes outings along the Bruce Trail itself but also on footpaths around the entire Niagara Peninsula. The Niagara Club's membership numbers close to 700 individuals and families. There are over 100 active volunteers who put in many hours maintaining and protecting the trail, leading hikes, stewarding land, contacting landowners and organizing special events.

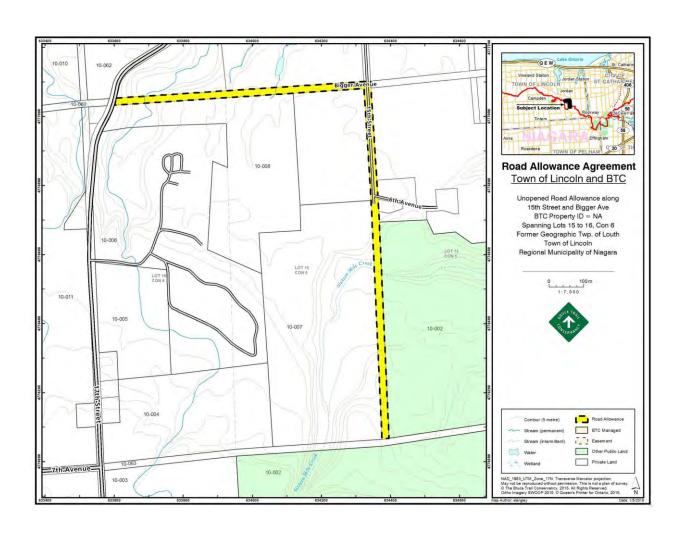

Current Trail and Proposed Re Route

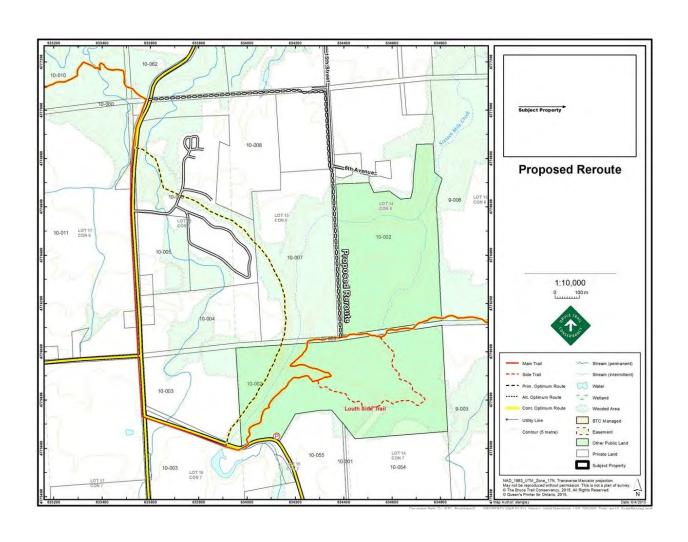
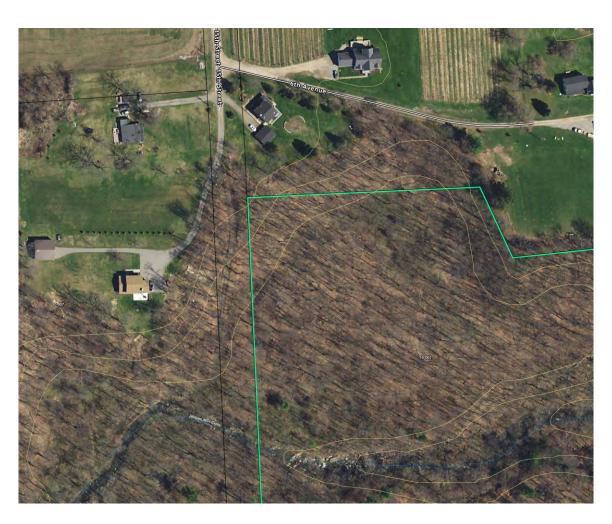
