Following the various requests and concerns expressed by the members, Chair Annunziata clarified that any additions, deletions, revision, or recommended changes to the RFP requested by the board, are out of order specific to the motion this board passed (January 18, 2017). Further, as per the motion, the RFP document as presented has been independently produced by the Region of Niagara representatives, the City of Hamilton representatives and NPCA Acting CAO. Haldimand County representatives chose not to participate in this process. With respect to the concern expressed by some members regarding the exclusion of motions by the various municipalities in the RFP; Annunziata stated that the RFP speaks specifically to addressing those concerns brought forward by the municipalities and that this board will not modify this document in any way.

Clarification by board was requested, that once this RFP document is issued, there is no involvement from the board in selecting the proponent. Chair Annunziata responded affirmatively stressing this process is independent of the Board as per the motion and that the board has entrusted that process to members at the Region, City of Hamilton and the Acting CAO for NPCA.

In response to a member's inquiry about an opportunity to engage the Auditor General in phase two, Chair Annunziata responded that should a phase two be required, "the Auditor General has committed to helping in that process down the road, given her schedule, and the timing of that opportunity. That has been very well communicated to the board and certainly to the public. The Auditor General is very well aware of our process, she respects our process, and hopefully the goodwill gesture she extended will be available in the event that we do require a phase two and a deeper dive."

It was noted that a copy of this RFP has not as yet gone to Haldimand County, however, NPCA staff will follow up on that to ensure they too are kept up-to-date with the progression of this Operational Review.

The Chair commented that once the independent consultant is brought on board, they will have full access to everything and they will decide what material they choose to include in their review.
