3. **Business Arising from the Minutes**

Member Hodgson, asked the Chair to clarify "where exactly in the motion that was passed on Jan 18," (regarding the draft RFP) "does it say that the board suspends it's authority to amend, make decisions; because as the author of the motion, the clear intent and spirit was empowering the board hold itself to account and the only restrictions were limiting the staff. How is it that we had to approve the Draft RFP, with no comments?"

Referencing Hodgson's "motion", Chair Annunziata noted that there is no opportunity for the board involvement in the selection process of the consultant, the motion specifically enables the Acting CAO, Niagara Region, City of Hamilton and Haldimand County "to immediately initiate an independent and thorough third party operational performance assessment" (Point 2 of motion). "They have been entrusted in the RFP process, which was put to public tender on March 10th and will close on April 9th. That process has already been completed. Once the consultant is chosen; not by this board; the board would be re-engaged at Point 5 of the motion. The consultant will be introduced to the board and at that time, the board will have the opportunity to direct the reporting mechanism. The independent selection process was followed according to the motion."

Chair further clarified that the email sent by Mr. Reles to Mr. Hodgson was specifically "to address derogatory comments he made about colleagues." Respecting member Hodgson's biggest concern about changing "direct to" to "directed to" in the motion, the Chair is confident that the spirit and intent of the motion have not changed. "There was no ill intent, no ill spirit, it does not compromise the will of this board and accepts Mr. Graham's explanation of a grammatical change. If your concern is the reporting mechanism, this board will have full opportunity to address the consultant with those concerns. The grammatical change does not impact the selection process of the independent consultant."

5. Chair's Remarks

The last month NPCA has been involved in some great initiatives;

- Staff hosted the Invasive Species workshop held yesterday (March 28). It was a great learning opportunity to inform many of our municipalities on the diverse species.
- The Chair met with many of our partners in the community, conservation and environmental clubs; one concern repeated was the renewal of membership and funding opportunities to help with some of the issues that these conservation groups have challenges with. It is our hope moving forward that we can support these groups and if there is any chance to partner with any initiatives they have and to lend support and advocacy. The board member representing the community of a particular club, will be copied on correspondence moving forward so that board members are aware what those challenges are.

• The International Joint Commission Public Meeting regarding the health of the Great Lakes will be held this afternoon 1:30pm Rowing Club, Henley Island St. Catharines. Of significance was the Fort Erie Council Meeting on Monday evening where Mayor Redekop passed a motion calling on all levels of Government (Canadian and US) to properly fund some of the initiatives we've been working on for the past 10 years. With the funding cuts being made in the US, the motion was specifically asking the US to reconsider and not cut funding. There is a joint effort with the Mayors that are part of the Great Lakes committees and Chair Annunziata will certainly bring that concern to Minister of Environment, McGarry at Queen's Park.

6. **Acting CAO Remarks**

- P. Graham provided an update on The Living Landscape Policy Review. Following recent meetings with the Core working group, the CLAC committee and area planners, it is the goal of NPCA staff to have a draft document to the board by the April 26 meeting. At that time we will ask the board to release the document for public consultation.
- On March 8th we held the 2017 Niagara Envirothon Event at Ball's Falls. It is North America's largest high school environmental education competition. This unique program reaches almost half a million students across North America.
- In partnership with Niagara's Twenty Valley, public event, "Roots on the Twenty" will be held at Ball's Falls on May 27-28. Future updates will be provided.
