#### **RECOMMENDATION:**

- 1. That Report No. SPA 01-18 respecting the Source Protection Committee Appointment **BE RECEIVED**; and
- 2. That the Source Protection Authority **APPOINT** the individual identified in Confidential Appendix 1 to Report SPA 01-18 as the member representing the Industrial Sector to the Source Protection Committee.

#### PURPOSE:

The Industrial Sector position on the Source Protection Committee is currently vacant. To fill the vacancy, it is presented to the Source Protection Authority for its consideration, the appointment of the individual as member representing the Industrial Sector, to the Source Protection Committee.

#### BACKGROUND:

The Source Protection Committee (SPC) is a body that exists to support the Source Protection Authority in the delivery of the Source Water Protection Plan. The SPC identifies matters of policy, or technical issues, and makes recommendations to the Source Protection Authority for their consideration. The SPC is comprised of 9 members and a Chair. The members represent municipalities, the industrial sector, the agricultural sector, the commerce sector, and the public-at-large. Members are appointed by the Source Protection Authority board while the Chair is appointed by the Minister of the Environment and Climate Change.

This vacancy was advertised September 30<sup>th</sup> through social media on NPCA's website, the Source Water Protection web-site, Facebook and Twitter. The opening was also promoted to the Niagara Community Awareness and Emergency Response Group (<u>www.niagaracaer.com</u>), an initiative of the Chemistry Industry Association of Canada.

Applications for the Industrial representative were reviewed by the Source Protection Committee Chair and the Supervisor of Special Projects. Applications were evaluated based on the following criteria:

- Strong knowledge of drinking water source protection science and concepts;
- Experience with reviewing technical reports;
- Knowledge of the Niagara Peninsula and related drinking water issues;
- Proven communications skills; and
- Experience working on multi-sector committees.

Through this evaluation process, the individual was acknowledged to be the preferred candidate.

Both the Source Protection Committee Chair and the Supervisor of Special Projects are confident that the individual will serve to advance the ability of the SPC to support the Source Protection Authority. As such, it is recommended that the Source Protection Authority confirm this nomination.

#### **RECOMMENDATION:**

#### PURPOSE:

To satisfy the requirements of the Source Protection Committee Regulation (O.Reg.288/07).

Appointment of the Region of Niagara and County of Haldimand representatives to the SPC would be until December 31, 2018, following the fall 2018 municipal elections.

Appointment of the Agricultural sector representative and the public-at-large representative to the SPC would be for five years (a period ending January 2023).

#### BACKGROUND:

The Source Protection Committee (SPC) is a body that exists to support the Source Protection Authority in the delivery of the Source Water Protection Plan. The SPC identifies matters of policy, or technical issues, and makes recommendations to the Source Protection Authority for their consideration. The SPC is comprised of 9 members and a Chair. The members represent municipalities, the industrial sector, the agricultural sector, the commerce sector, and the public-at-large. Members are appointed by the Source Protection Authority board while the Chair is appointed by the Minister of the Environment and Climate Change.

The Region of Niagara and County of Haldimand representatives were appointed for 3 years in 2015 (reports SPA 02-15 and SPA 06-15, respectively) prior to the province revising the Source Protection Committee Regulation 288/07 (in 2015) allowing for terms lengths up to five years.

Appointment of the Agricultural sector representative to the Source Protection Committee (report SPA 08-15) was on an interim basis prior to the regulation changes in 2015. The publicat-large representative was appointed to the SPC in 2015 (report SPA 07-15) for a period of 3 years.

These appointments are supported by the Source Protection Committee Chair and the Supervisor of Special Projects. These individuals are valued members of the committee with a strong knowledge of the source protection program in Niagara.
