WHEREAS the Niagara Escarpment, from Queenston in the south to Tobermory in the north, has been recognized by the United Nations Educational, Scientific and Cultural Organization (UNESCO) as a World Biosphere since 1990;

AND WHEREAS the Niagara Escarpment Biosphere (NEB) provides a range of very positive returns to Ontarians, including but not limited to promoting biodiversity of both flora and fauna, open landscape, productive agriculture and agri-tourism, traditional Indigenous knowledge and cultural history, eco-system services, a living laboratory for learning, carbon sequestration, climate change mitigation and adaptation;

AND WHEREAS oversight of the NEB has successfully transitioned from the Ontario governmental agency, the Niagara Escarpment Commission to a citizen-centred, not-for-profit organization, the Niagara Escarpment Biosphere Network (NEBN);

AND WHEREAS the NEBN has been established as a Co-Leadership model between Indigenous and Non-indigenous leaders, with a key objective of establishing the future direction of the NEBN as a model of delivering on the worthy goals of Canada's Truth and Reconciliation Commission as well as a demonstrated commitment to the United Nation's Declaration on the Rights of Indigenous Peoples;

AND WHEREAS the NEBN has made and continues to demonstrate its commitment to partner engagement and collaboration across many sectors and interests, including municipal, environmental, tourism, educational, youth, economic, research, and more;

AND WHEREAS the NEBN is seeking continuation of the official UNESCO Biosphere designation for the NEB, with the support of those who call the NEB home for work, play and study;

AND WHEREAS the Niagara Peninsula Conservation Authority reaffirms our commitment through our 10-year Strategic Plan to undertake work that supports the UNESCO Biosphere designation for the Niagara Escarpment;

THEREFORE, BE IT RESOLVED THAT the Niagara Peninsula Conservation Authority supports the continuation of the UNESCO Biosphere designation for the Niagara Escarpment and for the oversight model that has been established through the NEBN.



Official Plan Amendment 87 - Approved

The Amendment provides a site-specific "Low Density Residential (EX-RES-11)" designation to permit a maximum net residential density of 7.64 units/acre (18.87 units/hectare) for the subdivision development.


Zoning By-law 4316FC-24 - Approved

The By-law provides a "Residential (R2-39) Site-Specific Zone" to facilitate the subdivision development with provisions for lot coverage, building setbacks, building height and projection of porches, decks and patios.

Tawny Ridge Estates (Phase 1) Draft Plan of Subdivision 26T-18-22-02 - Approved The Draft Plan of Subdivision proposes 12 lots for single-detached dwellings with access onto Tanbark Road. A pedestrian walkway is also proposed in the plan. The Draft Plan and Conditions of Approval are attached to this Notice.



Official Plan Amendment 88 - Approved

The Amendment provides a site-specific "Low Density Residential (EX-RES-12)" designation to permit a maximum net residential density of 13.22 units/acre (32.66 units/hectare) for the subdivision development.



Zoning By-law 4316FD-24 - Approved

The By-law provides a "Residential (R2-H-40) Site-Specific Zone" and two "Residential (RM1-H-40) Site-Specific Zones" to facilitate the subdivision development with provisions for lot coverage, building setbacks, building height, garage door width, townhouse block frontage, maximum number of townhouses, landscaping, amenity space for townhouses and projection of porches, decks and patios, and to add a "Holding (H)" to require that the stormwater management strategy for the development is addressed prior to final approval of the draft plan of subdivision.

Tawny Ridge Estates (Phase 2) Draft Plan of Subdivision 26T-18-22-03 - Approved

The Draft Plan of Subdivision proposes 20 lots for single-detached dwellings, 24 on-street townhouses and land for either a maximum of 20 block townhouses or a maximum of 30 stacked townhouses with access to new streets. A pedestrian walkway is also proposed in the plan. The Draft Plan and Conditions of Approval are attached to this Notice.

The last date for filing a notice of appeal is February 28, 2024.

Purpose:

The purpose of this report is to provide the Board with an update of Human Resources actions during 2023.

Background:

The Board has expressed an interest in understanding the Human Resources actions at the NPCA. As a standard governance practice, staff will provide the Board of Directors with an update on Human Resources actions, initiatives, and basic reporting annually.

Discussion:

Recruitment & Selection

Following the guidance of the 2021-2031 strategic plan and corporate structure presented to the Board in 2022, we have continued to build staff capacity and required skills through hiring of new complement aligned with our strategic direction. We have additionally been successful in various funding opportunities that have allowed us to increase capacity in existing programs to support project specific opportunities. We have continued to experience hiring challenges in key areas such as planning and engineering. A range of recruitment approaches and updated compensation program is anticipated to assist with recruitment in these areas going forward. Internal promotions through appropriate hiring practices have been an effective talent management tool in 2023. The internal promotion of 7 staff supported professional & career growth of skilled staff with the NPCA supporting our organizational structure with a full-time complement of 76 staff.

Funding Applications for to support Youth and Student internship opportunities

Grant applications were submitted for a number of wage subsidy programs over 2023 targeting valuable youth employment experiences. By providing opportunities for youth in the areas of Conservation Areas, Climate Change, Restoration, Water Resources and Communications, NPCA was fortunate to have youth wage subsidies for a total of \$32,060.

Talent Management Strategy

A Talent Management Strategy in line with the 2021-2031 NPCA Strategic Plan was developed in 2022. During 2023 we initiated execution of various components of the Strategy. The biggest initiative was the Comprehensive Compensation Review. This extensive review was completed through a third party in 2023, including consultation with the bargaining unit throughout the process. Results of the study were presented and approved by the Board in November 2023. The results of the study are expected to be implemented in 2024, within the approved budget parameters. Additionally, Comprehensive Compensation Review will further support attraction and retention of top talent through a competitive and fair compensation structure that is aligned with the corresponding job market and geographical area.

We additionally refined the performance management system, creating a process that aligns with NPCA's defined values and guiding principles. Incorporating inclusive feedback mechanisms, discussing training needs and future ambitions will assist us in further developing our workforce towards achieving our organizational priorities along with facilitating personal growth.

Staff Survey and Feedback



Staff have provided feedback in the areas of communication, growth & development, customer service, organization and culture, employment conditions, health & safety, engagement, workspace, wellness and motivation. We will be using this data to consider strategies to continue to improve our workplace and will be sharing and updating an action plan with staff in the coming weeks.

Health & Safety

In 2023, in support of ensuring a proactive culture of safety, NPCA hired a health and safety and human resources representative. This incumbent has performed an audit of NPCA health and safety policies and procedures and has begun working with staff to ensure best practices are being implemented and supported throughout the organization.

2023 incident/accidents saw no change in number of employee injury/illnesses over the past 2 years and NPCA continued to have no lost time claims.

Visitor/guest incidents/accidents on our properties continue to decrease as we implement various self-education checkpoints throughout our Conservation Areas

Purpose:

To provide the Board a final report on key transition requirements by January 31, 2024 as per Ontario Regulation 687/21: Transition Plan and Agreements under the Conservation Authorities Act.

Background:

Section 21.1.2 of the Conservation Authorities Act stipulates that an authority may provide programs and services that it determines are advisable to further the purposes of the Act. These programs and services are in addition to Mandatory programs and services in Section 21.1 and Municipal programs and services in Section 21.1.1. These programs and services shall not be provided by the authority unless an agreement has been entered into between the authority and participating municipality regarding said services.

Ontario Regulation 687/21 outlines Transition Plan and Agreements under section 21.1.2 of the Conservation Authorities Act, indicating that January 1, 2024 is prescribed as the transition date for section 21.1.2 of the Act. A final inventory of programs and services offered, and confirmation that necessary cost apportioning agreements have been entered into, are to be submitted to the Ministry within 30 days of the transition date.

Discussion:

The intention of this report is to inform the Board that the NPCA has fulfilled requirements outlined for a successful transition as of January 1, 2024 as required by O. Reg 687/21.

Staff provided a Final Transition Report to the Ministry of Environment, Conservation and Parks (MECP) and the Ministry of Natural Resources and Forestry (MNRF). This included an inventory of programs and services and details pertaining to the execution of Service Level Agreements with Haldimand County, the City of Hamilton, and Niagara Region.

NPCA's Inventory of Programs and Services, and Service Level Agreements with partnering municipalities can also be found in the *Governance* section on NPCA's website

Financial Implications:

Amendments to the *Conservation Authorities Act* have resulted in an extensive amount of workload for staff over the past few years. Priorities are being addressed within the current budgetary restraints by appropriately prioritizing through workplans and leveraging external funding support as appropriate.

Purpose:

The purpose of this report is for the NPCA Board of Directors to consider and approve the proposed 2024 and 2025 Third-Party Fundraiser Event at Ball's Falls Conservation Area delivered by 365 Sports Inc. in support of the Make-a-Wish Canada.

Background:

In 2021, the NPCA Board of Directors approved the delivery of the 5k Foam Fest, a thirdparty fundraiser event, at Ball's Falls Conservation Area delivered by Ontario-based sporting events company, 365 Sports Inc. This event operator has considerable experience programming events in natural areas, including Wasaga Beach, an ecologically significant area, as well as other conservation areas in Ontario including Albion Hills and Claireville Conservation Areas through partnership with Toronto and Region Conservation Authority (TRCA).

The 5k Foam Fest, is a family-oriented fun run, accessible to diverse abilities and ages that supports the Make-a-Wish Canada Foundation and raises awareness of children's illnesses and grants wishes to children who are critically ill. This event is held at venues across Canada and Australia annually and is hosted each year within a Niagara-based venue. In 2023, 365 Sports raised over \$150k for Make-A-Wiah. 365 Sports Inc. deliver events and programming following a detailed emergency action plan and following

thorough health and safety guidelines and event practices that align with regional public health guidelines and municipal by-laws.

The last Foam Fest event hosted at Ball's Falls Conservation Area took place on August 20, 2022. The event was very well attended and reached full capacity as anticipated by 365 Sports and the NPCA. The 2022 event was delivered successfully, with a few key areas where important lessons were learned. NPCA staff determined that any future iteration of this or other similar events would be required to make adaptations to best manage traffic flow, parking and communications.

The NPCA typically approves one or more site use agreements for similar events and programming annually. These agreements help support NPCA's strategic objectives of connecting people with nature through increased awareness and access to conservation areas to new demographics and promote active recreation and conservation principles. Site use agreements for third party events are common among Conservation Authorities across Ontario, where active-use conservation areas make for ideal and desirable settings for the delivery of small-to large-scale public events and programs aligned with conservation authority values. Site use agreements may be structured as short term (single event, single year), or longer-term (single event, multi-year).

Site use agreements are structured to detail whether the event or program is a public or private event, the type of site infrastructure or staff resources required, and whether the event requires exclusive site access. When considering applications for site use, NPCA staff review the ecological, social and financial impacts of the program. Areas of priority in the review of programs include: reduced site and staffing impacts, little to no ecological impacts, events open to the public for participation, promote conservation and recreation, support charities, and generate revenue for the Authority.

Discussion:

In late 2023, 365 Sports requested approval from the NPCA to enter a site use agreement to host the family 5k Foam Fest at Ball's Falls in summer 2024 and again in 2025. In response, the NPCA requested a draft event management plan, including reference to risk and traffic management/ parking plan and a proposal on the implementation of the event around Ball's Falls' existing event and bookings calendar.

365 Sports has since returned to NPCA staff with a fulsome event management plan that satisfies NPCA staff requirements and recommendations. The proposed 2024 and 2025 events have been planned to ensure the delivery of safe, inclusive and accessible family recreation, along a course route with minimal environmental and operational impacts. Further, event organizers are flexible and will adapt the program to the NPCA's site needs and operations at Ball's Falls Conservation Area. The proposed event timeline has been designed to accommodate regular site use, including day-use visitation, Bruce Trail access, educational programming, and wedding venue rentals. This will ensure that regular area operations and revenue-generating activities at Ball's Falls will not be negatively affected.

In 2024 and 2025, 365 Sports Inc. anticipates approximately 3,000-4,000 participants at the Niagara event. Participants arrive and participate in the event in two-hour heats over an eight-hour period. This is approximately half of the number of visitors observed at the Thanksgiving Festival daily.

NPCA staff recommend the approval of this third-party event at Ball's Falls Conservation Area in August 2024 and 2025, should all NPCA requirements be met in 2024. Staff make this recommendation as the proposed event aligns with the current Master Plan for the Conservation Area, involves minimal staff involvement, and will create a minimal impact on the site and operations. Further, this large-scale family event is considered low-risk, and is promoted to participants from across southern Ontario, supporting the increased profile of the NPCA as well as Ball's Falls. The alignment of the Family 5k Foam Fest with Make-A-Wish Canada children's charity is synergistic with Goal 3.1 of the NPCA's Strategic Plan and supports the delivery of inclusive and accessible active recreation within a natural setting.

Financial Implications:

There are no additional operating costs for NPCA to provide site use and access for this third-party event. A net revenue of approximately \$12,000 plus HST in site rental fees is anticipated through this agreement for 2024. In addition, non-tangible benefits will be accrued, such increasing awareness of the NPCA, introducing new visitors to Ball's Falls Conservation Area, as well as supporting fundraising efforts directed towards children's health and wellbeing through Make-A-Wish Canada.

Purpose:

The purpose of this report is to provide the NPCA Board of Directors an update on the organization's strategy for managing the total solar eclipse on April 8, 2024.

Background:

On April 8, 2024, a total solar eclipse will take place across the Niagara Watershed. This extraordinary and infrequent celestial occurrence is poised to unfold over Canada, the United States, and Mexico. A total solar eclipse occurs when the Moon passes directly between the Earth and the Sun, blocking the Sun's entire disk from view. This celestial alignment results in a temporary darkening of the sky as the Moon obscures the Sun's light. During a total solar eclipse, the Moon casts a shadow on Earth, and observers within the shadow's path experience a brief period of complete darkness known as totality. During this event, the moon will perfectly align between earth and the sun, casting temporary darkness over select regions of the country and enchanting a multitude of spectators. The anticipated commencement of the solar eclipse is at 2:04pm, spanning approximately 2.5 hours. The sun will reach a complete eclipse between 3:20pm and 3:23 pm.

Notably, the Niagara Watershed is one of the prime locations in Canada to witness this celestial spectacle, providing over three minutes of total eclipse. Significantly, Fort Erie is within the Line of Totality, in which a complete eclipse can be observed. A century has passed since Niagara last experienced a full solar eclipse in 1925, and this phenomenon is not expected to recur until the year 2144.

Caution is paramount when observing the solar eclipse. Directly viewing the sun with the naked eye poses risks, as exposure to solar UV and IR radiation can lead to retina damage and eyesight impairment. To safely witness the solar eclipse, it is imperative to utilize international standard (ISO) certified eye protection glasses equipped with special filters. These glasses ensure the safe observation of all phases of the solar eclipse and mitigate potential harm to one's eyesight.

Discussion:

The NPCA has been actively involved with key stakeholders in planning for the solar eclipse on April 8th. Key NPCA staff participate on the Niagara Region's Emergency Management Committee and the NPCA supported the committee by hosting a solar eclipse emergency exercise that allowed response organizations an opportunity to practice their responses to scenarios. NPCA staff have also collaborated with municipalities through the Parks and Recreation Committee. Due to the Niagara Watershed being one of the prime locations to witness the total solar eclipse the NPCA has taken several initiatives to provide safe viewing as well as precautions to enhance health and safety for park visitors and NPCA staff.

Programming at NPCA's Active Conservation Areas

The NPCA's four active parks will present a unique opportunity for visitors to witness a total solar eclipse. To facilitate this extraordinary experience, all four parks will temporarily open before their traditional season, allowing individuals to marvel at this celestial event amidst the stunning natural landscapes of the Niagara Watershed.

At Long Beach, CA, a total of 75 tented camping sites will be available in the main day use areas, accompanied by 50 day-use vehicle spots for optimal viewing in the beach area. Ball's Falls will provide 75 tented campsites in their campground area (Festival Parking) and accommodate day-use vehicles within the Centre for Conservation Parking Lot. Chippawa Creek is set to offer 20 tented campsites in their Riverview camping area and an additional 60 day-use vehicle spaces for observing the eclipse in the main day use area. Binbrook CA will make available 200 day-use vehicle spots for viewing in the main day use area.

Access to the four Active CAs for overnight camping and day-use on April 7th and 8th will be managed and issued in advance through the NPCA's Reservation website and system operated by Camis. Potential overnight guests and day-use visitors will be required to purchase their tent camping permit or day-use pass in advance through the NPCA's Reservation system. Camping and day-use permits are limited and "walk-ins" or day-of arrivals will not be permitted. The NPCA is employing a strategic informational marketing plan to both advertise and promote these opportunities to observe the solar eclipse safely from within the NPCA's active conservation areas, as well as advise the public that access is limited to permit holders only on the day of the eclipse.

These service offerings have been thoughtfully determined, employing a balanced approach to provide a significant number of individuals with the opportunity to witness the eclipse, all

while maintaining the integrity of the grounds and prioritizing the health and safety of the visitors.

Closure of NPCA's "high-risk" Conservation Areas

NPCA staff will collaborate with municipal emergency services to restrict access to high-risk conservation areas during the solar eclipse event to minimize risk to health and safety. Those high-risk areas include all of NPCA's conservation areas which feature trails in close proximity to significant cliffs, primarily NPCA's escarpment properties, as well as those areas adjacent to or featuring significant watercourses or waterbodies. These properties, such as Woolverton, Beamer, Mountainview, Cave Springs, Jordan Harbour, E.C. Brown, Louth, Rockway, St.Johns, Wainfleet Wetlands, and Woodend, will be subject to measures aimed at ensuring public safety. In addition to implementing physical barricades, the NPCA will employ signage and leverage communication channels through its website, mailing lists, and social media platforms to disseminate information and discourage visitors from entering these specific parks during the day of the solar eclipse.

<u>Updated Park Emergency Plans</u>

In collaboration with the NPCA's Joint Health and Safety Committee (JHSC), NPCA park staff will conduct a thorough review of the existing park emergency plans, incorporating a dedicated section to address the nuances of operation during a unique, high-risk event, such as a solar eclipse. The revised emergency plans will encompass detailed provisions for emergency and notification procedures, evacuation protocols, coordination with emergency services, medical response, weather-related contingencies, and strategies for public communication.

To ensure the effectiveness and compliance of these updates, the emergency plans will be updated in consultation with and approval from the JHSC. This collaborative effort aims to enhance the emergency preparedness of the parks, specifically tailoring the plans to address the distinctive challenges associated with hosting a solar eclipse event.

Communications

The NPCA is set to establish a dedicated page on its website to relay information to the public regarding the upcoming solar eclipse. This webpage will serve as a central hub, offering details on service offerings and reservation procedures for parks providing specific programming. Additionally, it will provide crucial information about park closures and essential safety guidelines, ensuring the public is well-informed and can plan their eclipse experience.

Additional precautions for NPCA staff

As NPCA staff regularly work in the field, we will be taking extra precautions to ensure the safety of our staff. All staff will be provided with ISO certified eye protection glasses. As we anticipate that traffic may be severely congested during the period of the solar eclipse,

NPCA will be advising staff to not schedule any site visits on that date unless necessary and additionally encouraging all those that are able to, to work remotely on April 8th. Staff that will be working in the field will additionally be involved in a thorough review of the updated emergency response plan. All staff will receive educational guidance on safety precautions to take during this unique event.

Financial Implications:

The NPCA has allocated funds for the total solar eclipse within its 2024 operating budget. There are no financial implications outside of the operating budget.

Purpose:

The purpose of this report is to update the Board of Directors on the completed acquisition of the Lathrop Parcel located at 130 Luffman Drive, Part Lot 3 Concession 4, Town of Pelham, Regional Municipality of Niagara. The report further recommends that NPCA's local and regional municipality, within which the property is located, be informed of this acquisition.

Background:

The Niagara Peninsula Conservation Authority (NPCA) Board of Directors approved the Land Securement Strategy (LSS) in December 2022 via Resolution No. FA-128-2022. Approval of the LSS was a significant achievement for NPCA and supports Goal 1.4 of NPCA's 2021-2031 Strategic Plan – Managing NPCA lands to increase biodiversity, habitat connectivity, and natural cover. The NPCA has adopted a 180 hectares by 2031.nimum of

Through two separate Resolutions in 2023 (No. FA-59-2023 and No. FA-95-2023), the NPCA Board of Directors directed staff to pursue and negotiate the acquisition of 8 parcels throughout the watershed based on an estimated value for each property and an overall upset limit for all priority parcels. One potential acquisition, the Lathrop successfully negotiated in 2023, with final transfer on January 12, 2024.

Discussion:

The Lathrop Parcel is 26 hectares (64 acres) that includes a mix of natural features, agricultural land, and residential improvements. The landowner is from the same family that sold the original Lathrop Conservation Area to NPCA in 2011. NPCA was interested in a roughly 18 hectare (44 acre) portion of the property that included most of the natural features, while the landowner would retain 8 hectares (20 acres) that included their residence and other property improvements.

The parcel is located within the Niagara Escarpment Plan area and designated Escarpment Natural and Escarpment Protection. The parcel is also part of the Effingham Forest Life Science ANSI. It provides cold water fish habitat and has presence of one Species at Risk (American Chestnut) on the north part of the parcel. Informal trails already exist and may be ideal to connect to adjacent NPCA properties with additional acquisitions. This property is also within one of the six landowner outreach focus areas (St. Johns/Shorthills) as identified in the LSS.

The landowner connected with NPCA staff in late 2022 and expressed interest in selling a portion of their escarpment property. After an appraisal was completed to determine fair market value, NPCA staff were able to negotiate a per acre purchase price within market value. With verbal agreement on the per acre value, NPCA staff completed several due diligence studies including a Phase 1 Environmental Site Assessment and legal survey. After the property survey was completed the final property size to be purchased by NPCA was assessed at 17.8 hectares or 43.96 acres.

There are no immediate plans to open the property for public access. Future uses will be determined through a management plan process. Land Care staff will ensure property boundaries are marked with NPCA signage as needed to limit risk and liability.

The landowner intends to work with NPCA and Niagara Peninsula Conservation Foundation (NPCF) staff to share their story and connection to the watershed. This story will be one part of support materials used by staff and Board members from NPCA and NPCF to secure additional acquisition opportunities and solicit private donations in support of NPCA's Land Securement Strategy and the NPCF Nature For All campaign.

Financial Implications:

Funding to support this project was leveraged between two funding sources – the 2023 Niagara Region land acquisition support of \$234,000 and the Ministry of Environment and Climate Change Canada (MOECCC).

With support from Conservation Ontario, the MOECCC is providing acquisition funding through the Nature Smart Climate Solutions Fund (NSCSF). The NSCSF is a funding

program implemented to help achieve several Federal targets for habitat enhancement, restoration, stewardship, protection, and others. This includes Canada's 30x30 targets to protect 30% of lands and waters by 2030. The Lathrop parcel will further enhance NPCA's existing contribution of over 1600 hectares to the 30x30 initiative.

Links to Strategic Plan:

Securement of the Lathrop Property supports the NPCA strategic plan that led to the development and implementation of a LSS to achieve Goal 1.4: "Manage lands to increase biodiversity, habitat connectivity, and natural cover". Implementing the LSS through securement of properties also directly supports achieving Goal 3.1 "Create equitable access to greenspace for the health and well-being of people" as well as several other NPCA strategic goals and performance measures related to natural hazard protection, ecosystem improvements, and building relationships with partners, stakeholders, and Indigenous peoples.

Purpose:

Background:

As per Section 3.1 of the NPCA Administrative By-Law "The annual meeting of the NPCA Board will occur on the third Friday of February."

At the December 15, 2023 meeting of the Board, members verbally agreed to move the AGM to coincide with the grand opening of the Authority's head office relocation at 3350 Merrittville Hwy in March 2023.

Discussion:

The NPCA Head Office Transition Team has been working diligently on a seamless relocation for staff and regularly provides status updates internally. It was recently

indicated that work required to ensure technological requirements are in place and tested would not be completed to appropriately facilitate the AGM at the new location by March 22, 2024. Staff anticipate that all work required will be completed in early April and suggest that the Board consider revising the date of the AGM to April 19, 2024.

The proposed April 2024 date also coincides with the 65th anniversary of the establishment of NPCA in April 1959, presenting an excellent opportunity to include the celebration along with the head office relocation.

The recommendation does not alter the number or frequency of meetings for the Board. Full Authority Meeting would carry on as scheduled for both February 16, and March 22, 2024.
