

## BINBROOK

<b>SPECIES</b>	Controlled waterfowl hunting only.
<b>SEASON AT SITE</b>	4th Saturday in September to 2nd Saturday in December (if unfrozen lake conditions). <ul style="list-style-type: none"> <li>▪ Saturday only.</li> </ul> Check npca.ca website for possible changes.
<b>HUNTING AREA</b>	Hunting from designated blinds only. Hunting Blind Fee applies (max. 2 people per blind).
<b>NOTES</b>	NPCA Hunting Permission obtained daily at this site with hunting blind fee. Call 905-692-3228 for hunting blind reservation. <ul style="list-style-type: none"> <li>▪ First two weeks of hunting season - Lottery draw system for use of blind. Separate Hunting Blind #5 Lottery for season.</li> <li>▪ Application deadline is August 31. Contact our NPCA office or npca.ca for more details.</li> <li>▪ Park gate opens for registration 5-6 a.m. Hunting until noon.</li> <li>▪ Park gate closes at 1 p.m.</li> <li>▪ Access by boat/canoe/kayak - electric motor only.</li> </ul>

## CHIPPAWA CREEK

<b>SPECIES</b>	Hunting for deer, small game, wild turkey and waterfowl. No coyote hunting permitted.
<b>SEASON AT SITE</b>	<ul style="list-style-type: none"> <li>▪ Hunting permitted October 1 to end of February; April 25 to May 31.</li> <li>▪ Monday through Sunday</li> </ul>
<b>HUNTING AREA</b>	South side of Regional Road 45 only.
<b>NOTES</b>	Restricted areas in southwest block and northwest corner. Excludes building areas.

## HEDLEY FOREST

<b>SPECIES</b>	Hunting for deer, small game and wild turkey. No coyote hunting permitted.
<b>SEASON AT SITE</b>	Season as per provincial / federal regulations.
<b>HUNTING AREA</b>	Conservation Area boundaries.

## HUMBERSTONE

<b>SPECIES</b>	Hunting for deer, small game and wild turkey. No coyote hunting permitted.
<b>SEASON AT SITE</b>	Season as per provincial / federal regulations.
<b>HUNTING AREA</b>	Conservation Area boundaries.

## MUDLAKE

<b>SPECIES</b>	Controlled waterfowl hunting only.
<b>SEASON AT SITE</b>	Fourth Saturday in September to end of November. <ul style="list-style-type: none"> <li>▪ Monday, Wednesday, Friday and Saturday only.</li> </ul>
<b>HUNTING AREA</b>	Hunting from 3 designated blinds only (max. 2 people per blind).
<b>NOTES</b>	Access to hunting during posted times. Access to blind by water. <ul style="list-style-type: none"> <li>▪ First two weeks of hunting season- Lottery draw system for use of blind.</li> <li>▪ Application deadline is August 31. Contact our NPCA office or npca.ca for more details.</li> <li>▪ All hunting blinds have platforms for retrieving hunting dog.</li> <li>▪ Access by boat/canoe/kayak - electric motor only.</li> </ul>

## RUIGROK TRACT

<b>SPECIES</b>	Hunting for deer, small game and wild turkey. No coyote hunting permitted.
<b>SEASON AT SITE</b>	Season as per provincial / federal regulations.
<b>HUNTING AREA</b>	Conservation Area boundaries.

## WAINFLEET BOG

<b>SPECIES</b>	Hunting for deer, small game and wild turkey. No coyote hunting permitted.
<b>SEASON AT SITE</b>	Season as per provincial / federal regulations.
<b>HUNTING AREA</b>	Hunting in designated areas only. Refer to site hunting map. Entry off Erie Peat Road only.

## WAINFLEET WETLANDS

<b>SPECIES</b>	Hunting for deer, small game, wild turkey and waterfowl. No coyote hunting permitted.
<b>SEASON AT SITE</b>	Season as per provincial / federal regulations.
<b>HUNTING AREA</b>	Hunting permitted from east of Bessey Road and to west of Cement Plant Road boundary only.

## WILLOUGHBY MARSH

<b>SPECIES</b>	Hunting for deer, small game, wild turkey and waterfowl. No coyote hunting permitted.
<b>SEASON AT SITE</b>	Season as per provincial / federal regulations.
<b>HUNTING AREA</b>	Conservation Area boundaries.



## CONSERVATION AREA POLICIES

- Portable deer hunting stands permitted only. No spikes, nails or other material which damage trees.
- No cutting, destruction, and/or removal of vegetation in Conservation Areas.
- No ATV or recreational vehicles permitted within a Conservation Area.
- No baiting or trail cameras permitted in Conservation Areas.
- Boats with electric motors or paddle only on Conservation Area waters.
- No fires permitted. NOTE no smoking or open flame at the Wainfleet Bog Conservation Area due to extreme fire hazards.
- Retrieval dogs for waterfowl hunting only. No other use of hunting dogs permitted, to prevent disturbance of other animals and hunters.
- No target/range shooting in Conservation Areas (including sighting-in, clay throwing and plinking).
- No coyote hunting permitted.
