## Mud Lake Conservation Area 2019 Season - Controlled Waterfowl Hunting

The Niagara Peninsula Conservation Authority (NPCA) is pleased to be offering the Controlled Waterfowl Hunt at Mud Lake Conservation Area again this year.

For the 2019 waterfowl season, hunting will be offered **on Mondays, Wednesdays, Fridays and Saturdays** from 2 designated hunting blinds at the site.

The fees and lottery/ draw in effect for this year include:

- i) no fee for hunting blind this year
- ii) a lottery/draw will be held to reserve the use of hunting blinds for the first two weeks of the duck season (September 28 through October 11, 2019)
- iii) a NPCA hunting permit is required to hunt at this site. As part of this permission a hunting harvest report must be completed and received at the NPCA office by December 31, 2019. Failure to return the report will result in loss of hunting eligibility for 2020
- iv) Please note due to vegetation the third hunting blind is not accessible this year.

To be included in the lottery/draw, please complete the ballot below and **return** it by mail, email, facsimile, or in person, to our office no later than **August 31, 2019**. All applicants will be notified of results by regular mail/ email.

Please note hunting times will be posted at the site. They will be approximately ½ hour AFTER sunrise to ½ BEFORE sunset per NPCA policies. Should you require any additional information please contact Kim Frohlich at (905) 788-3135 ext. 241.

\*NOTE: Please visit the site beforehand to check site conditions. From October 12, 2019 onwards hunting blinds are on a first come-first served basis.
